### The Importance of Training & Assessment

The use of inadequately trained operators is a major cause of accidents. Even if such accidents do not cause a fatality or an injury, they will almost certainly lead to costly legal action or damaged equipment. Therefore, quality operator training is a must. A properly trained lorry loader operator is also a more profitable one, providing higher levels of efficiency and less down time, as well as a safer working environment. #### Quality of Instructors

ALLMI has over 150 accredited instructors throughout the UK and Ireland. All instructors hold recognised operator, slinger / signaller and instructional techniques, qualifications, and have extensive experience with lorry loaders. Every successful operator receives a certificate and identity card, as well as the ALLMI Operator Manual. ALLMI certification is valid for five years, after which time refresher training and assessment will need to be undertaken.

#### Driver CPC

It may be possible for operator training to count towards an individual's Driver CPC hours, as the ALLMI course is registered with the Joint Approvals Unit for Periodic Training (JAUPT). However, your ALLMI training provider must also become an approved centre for Driver CPC and register the training with JAUPT in advance of the course.
